The success of first pilot test of International Fast & Secure Trade Lane, realized within European project FENIX, lays the foundation for the harmonization of the document flows between the various actors involved in the Corridor

Realized within European project **FENIX** (coordinated by ERTICO at European level and by the Ministry of infrastructure and transport as recipient through TTS Italia at a national level) this pilot test saw the use of IoT (Internet of Things) technologies and eSeals with RFID electronic components with a numbered sequence which allows immediate identification of each container.

"We are excited and happy to have contributed to the success of this important pilot test of an International Fast & Secure Trade Lane capable of simplifying trade flows between the Ports of Trieste and Cesme in Turkey" said Luca Abatello, President & CEO at Circle.

As in the case of the other test concluded within European project **FENIX** between the Ports of Trieste and Pendik, the next stage previews a further activity exploiting advanced digitalization customs tools with the direct involvement of Italian and Turkish Customs and Monopolies Agencies.
