The contract has been awarded at a price of € 144,000.

The inclusion of this groundbreaking feasibility study in EMSA's portfolio of activities is set to support ship reporting procedures and requirements for European neighboring countries. The envisioned maritime single window environment holds the potential to bring about significant advantages, including streamlined information flows, automated verification and analysis of exchanged information, optimized data processing routines, and seamless data submissions throughout various stages of global supply chain trade and transport.
